APA Referencing Basics: In-Text Citation In-text references must be included following the use of a quote or paraphrase taken from another piece of work. In-text citations are citations within the main body of the text and refer to a direct quote or paraphrase. They correspond to a reference in the main reference list.

### How to Cite Sources in APA Citation Format - Mendeley

Parenthetical citations are placed at the end of a quote or paraphrase. These citations include a few details on the source (usually the author’s name or source title, and year published) within parentheses. Example: “When two cultures come together, the words of their languages compete for survival” (Crystal, 2013).

To cite the entire anthology or collection, list by editor (s) followed by a comma and "editor" or, for multiple editors, "editors." This sort of entry is somewhat rare. If you are citing a particular piece within an anthology or collection (more common), see A Work in an Anthology, Reference, or Collection below.

Basic book citation format The APA in-text citation for a book includes the author’s last name, the year, and (if relevant) a page number. In the reference list, start with the author’s last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).

Include an in-text citation when you refer to, summarize, paraphrase, or quote from another source. For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005).

In-Text Citation 1 Provide the first few words of the title in double quotation marks. At the end of any sentence in which you paraphrase or quote from the source, place a parenthetical citation that directs your reader to the full Reference List entry.

Title of Container, Names of other contributors along with their specific roles, Version of the source (if it differs from the original or is unique), Any key numbers associated with the source that aren't dates (such as journal issue numbers or volume numbers), Name of the Publisher, Publication date, Location (such as the location of specific page numbers or a website's address).

### MLA Format: Everything You Need to Know Here

Provide the title of the work. For a full video, place the title of the video in italics immediately following the first name or names that you listed in your citation. Use the same capitalization as in the video itself. If you're citing a shorter clip, put the title in quotation marks rather than in italics.
